

QUALITY ASSURANCE COUNCIL OF THE UGC

REPORT ON WORKSHOP ON FORMULATION OF SUBJECT BENCHMARK STATEMENTS

The workshop was held on 26 July 2019, in the Auditorium of the Postgraduate Institute of Management at 28, Lesley Ranagala Mawatha, Colombo 8.

The workshop was attended by 127 participants, representing the 15 subject based Standing Committees of the UGC and the Standing Committee on Quality Assurance. See Annex 1 for the programme and Annex 2 for the complete list of participants.

Proceedings

- 1. Preliminaries:** Prof Nilanthi de Silva, Director / QAC welcomed the participants and the resource persons, and explained the objectives of the workshop. Prof P S M Gunarathne, Vice-Chairman / UGC delivered the introductory remarks on the importance and usefulness of Subject Benchmark Statements (SBS) in the Sri Lankan higher education system.
- 2. Presentation 1:** Dr Fabrizio Trifiro, International Manager of the Quality Assurance Agency spoke on the **QAA's approach to Subject Benchmark Statements**, focusing on their origins, their place within the UK's quality assurance framework, and their development, maintenance and review. He explained at length the recognition process adopted by the QAA for development of new SBSs.
- 3. Presentation 2:** Prof Nilanthi de Silva spoke on **SBSs in the Sri Lankan context:** 39 have been developed to date, during the period 2003 - 2013 (see Annex 3 for full list). Revision is required because the Sri Lanka Qualifications Framework was first published in 2012 and then updated in 2015, and it is now necessary to ensure that all SBSs are consistent with the SLQF 2015, and presented in a common format. Moreover, the contents of the older SBSs need to be updated to reflect recent developments in the subject area. In addition, several new Subjects have been proposed for SBSs during the period 2017 – 2018. She also described the proposed composition of Subject Committees, who will be entrusted with the task of updating, revising or developing new Statements.
- 4. Presentation 3:** Dr Upali Mampitiya, member of the Standing Committee on Quality Assurance, presented the proposed **format for Subject Benchmark Statements**, with particular reference to ensuring compliance with the Sri Lanka Qualifications Framework.
- 5. Consensus decisions:** Following a general question and answer session, during which the resource persons provided clarification on issues raised by workshop participants, consensus was reached on the following matters.

5.1 Recognition process for new Subject Benchmark Statements

The process will be initiated by submission of a proposal from the subject community (which could be a network of academics or a professional body) to the QAC, with details of the subject area to be covered by the new statement; the universities and faculties that offer programmes of study relevant to the subject; the number of students currently enrolled in such programmes; the number of academic staff teaching the subject, and their levels of seniority; why the existing Subject Benchmark Statements are insufficient for the proposed subject; and the importance of the proposed subject area. See Annex 4 for draft application form.

Such a proposal would be assessed by the UGC's Standing Committee on Quality Assurance as well as the relevant subject-based Standing Committee. If both Standing Committees agree that the proposal provides adequate justification, the relevant Standing Committee will be requested to nominate members to the Subject Committee that will be appointed by the UGC to draft the newly proposed Subject Benchmark Statement.

5.2 Composition of Subject Committees

A Subject Committee should consist of 10 - 20 members, inclusive of university members and external stakeholders. University members (8 – 18 in number) should be representative of the universities that offer the Subject. They should hold the position of Senior Professor, Professor or Head of Department. The external members (at least 2) should represent important stakeholders outside the university system (industry / employers / professional bodies). The number of external members may be more (and university members proportionately less) in Committees for Subjects that are offered by only one university.

The Chairperson of the Committee will be nominated by the relevant subject-based Standing Committee. The Subject Committee may identify a suitable Secretary and/or Editor, from among its members at its first meeting.

Formal appointment of all members of the Subject Committee will be made by the Chairman, UGC.

Each Subject Committee will be supported by a member of the SC on Quality Assurance, in order to guide the development process in a consistent manner across all subjects.

The QAC will facilitate the process of convening meetings of the Subject Committees and publication of the final SBS.

5.3 Format of Subject Benchmark Statements

The following format is to be adopted for all Subject Benchmark Statements.

2 Degree programmes covered by this Statement

(The following points to be taken into account when applicable)

- (a) Some SBS may cover several related academic disciplines. For example, the SBS on Mathematics covers the subjects Pure Mathematics, Applied Mathematics, and Statistics and the SBS on Accounting covers the subjects titled as Accountancy, Accounting, Accounting and Finance, Accounting and Financial Management.
- (b) The Faculties of Arts, Humanities, Social Sciences and Science offer two categories of degree programmes at SLQF Levels 5 and 6. Most of the subjects in those faculties are taught at both levels. In such a situation, the SBS for a given SLQF level (i.e. qualification) should be interpreted using both the SBS and the SLQF level descriptors at the said level.
- (c) The minimum credit requirement for a subject taught at Level 5 degree programme should be 24 credits

- (d) The minimum credit requirement for subject taught at Level 6 degree programme should be 72 credits

5.4 Recommendations from individual Standing Committees

The specific recommendations made by each of the 15 groups representing the subject-based Standing Committees are presented in Annexes 5 – 19. Each of the members of the Standing Committee on Quality Assurance joined their relevant subject-based SC for these discussions.

It should be noted that in several instances, workshop participants were not the *ex officio* members of the Standing Committees, but their representatives, and they were therefore not in a position to make binding decisions. In such instances, their recommendations need to be endorsed by the Standing Committee at its next regular meeting.

The table below summarizes the SBSs proposed by each Standing Committee for revision and updating, and for recognition as new Subjects. A total of 31 Subject Benchmark Statements were identified for revision and updating, and another 54 new Subjects were proposed.

- 6.2 This report will be also submitted to the Standing Committee on Quality Assurance for (1) ratification of the format and procedure regarding recognition of new Subject Benchmark Statements, and (2) for assignment of a designated member to support each Subject Committee in its task of revising and updating Subject Benchmark Statements.
- 6.3 On receipt of the ratified list of members and designated Chairperson for a Subject Committee, the QAC will arrange for formal appointment of the members by the Chairman, UGC.
- 6.4 The QAC will convene the first meeting of the Subject Committee in consultation with its Chairperson. Subsequent meetings will be convened by the Chairperson or Secretary of the Subject Committee. The QAC will support publication of the finalized SBS in hard copy, and make it available in electronic form through its website.
