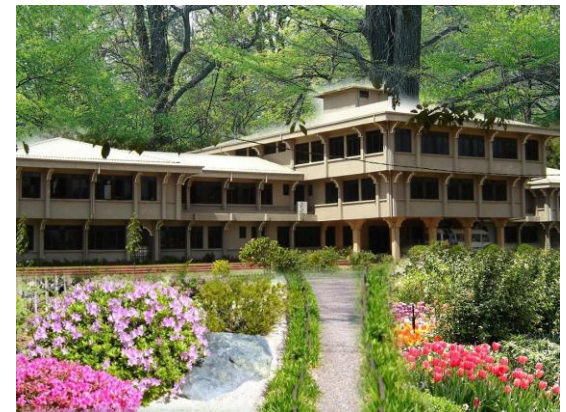

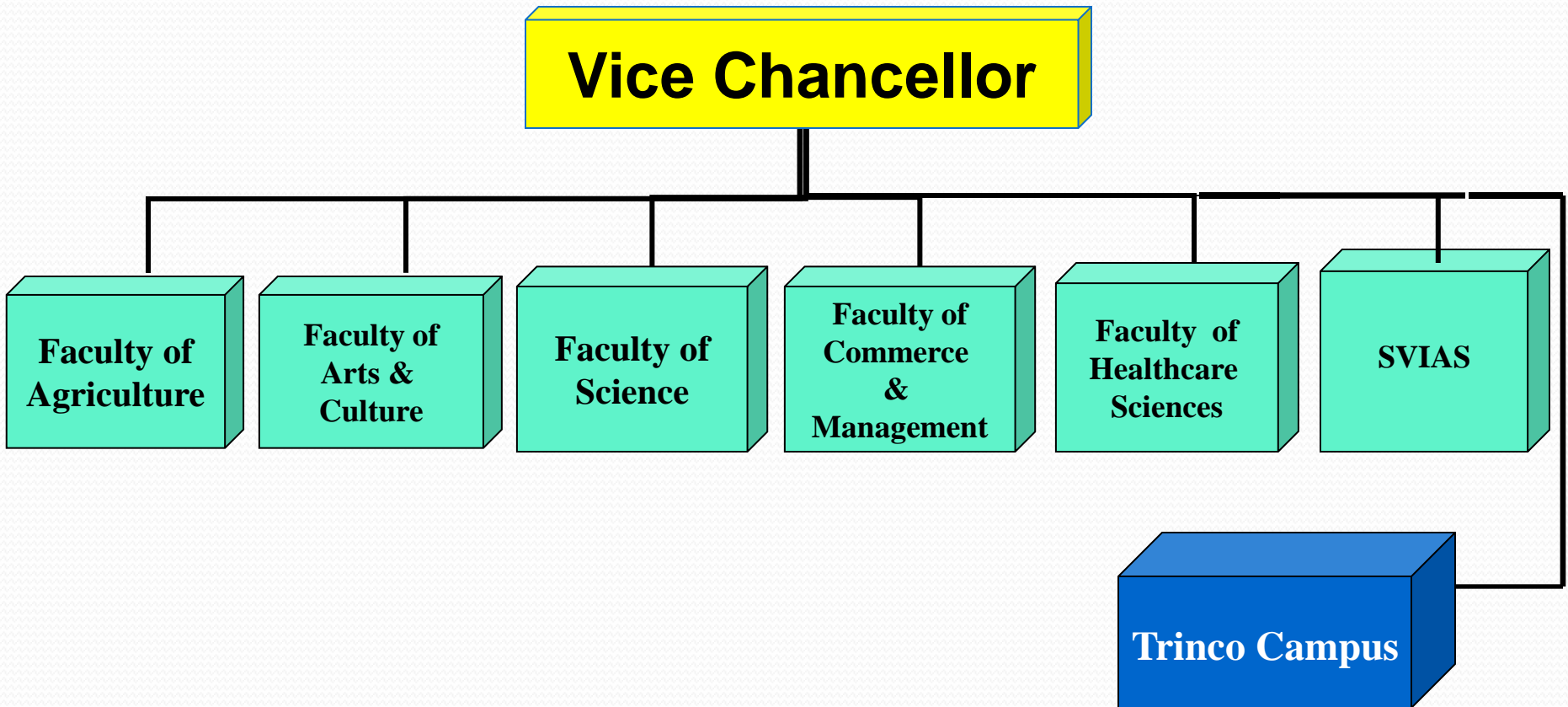

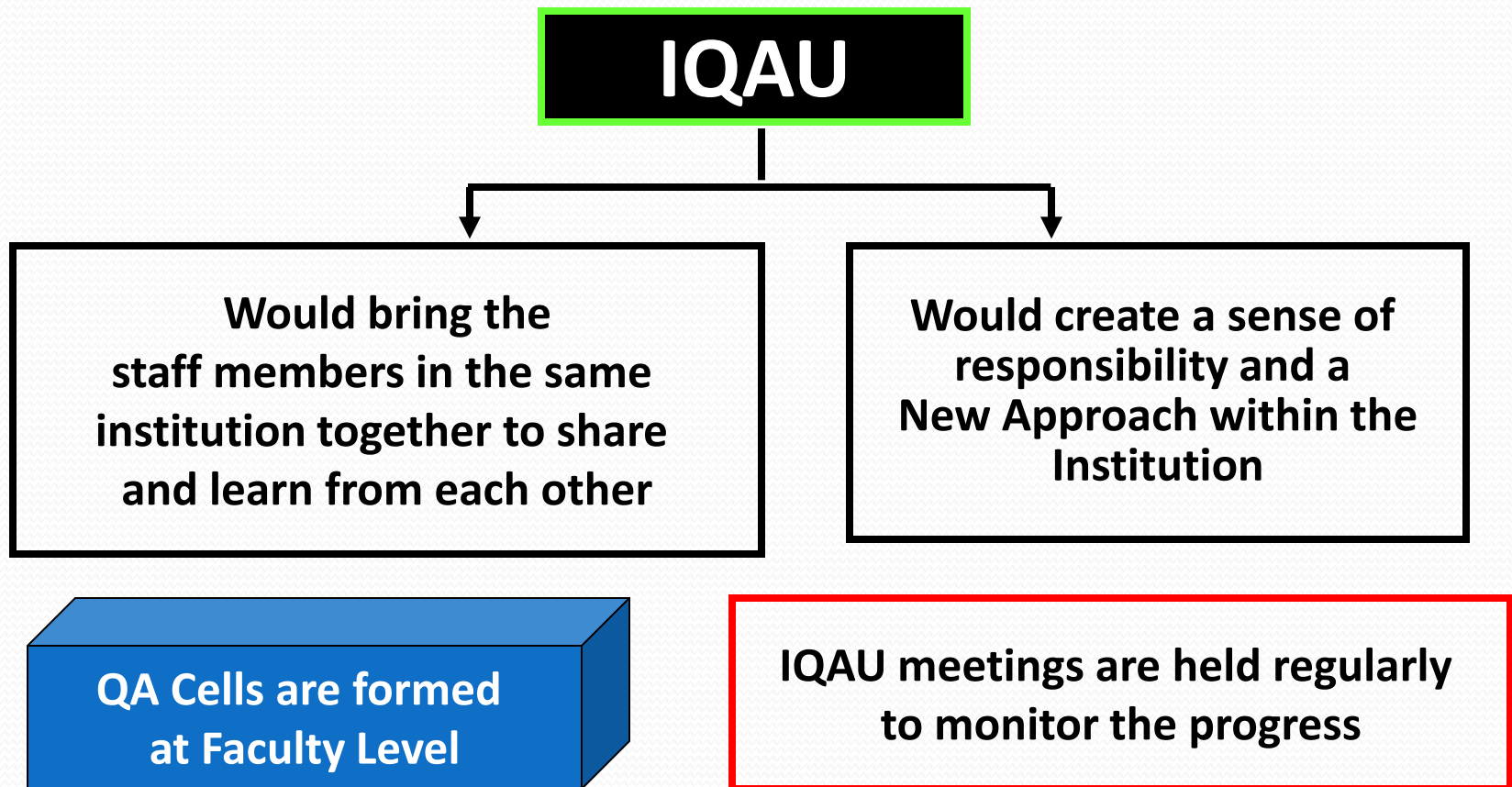

Best Practices of IQAU (3 best)

- * Included in Faculty , Senate and Council
- * Training the staffs to how to do student feed back analysis and to report to teachers teaches the subject
- * After the Institutional review EUSL council expects the faculty cell report the matters listed in the council by consultant to Vice chancellor to IQAU and it will reported to council each month about progress made in IR for improvements, changes etc.



Challenges in QA

- **Lack of Lecture / Laboratories / Examination Hall**
- **Inadequate Laboratory equipment, consumables**
- **Lack of Scientific Literature**
- **Slow Internet facilities**
- **In adequate computer facilities**



Constraints faced by IQAU (3 most pressing)

- * No financial allocation to IQAU via treasury funds to University
- * Only space is there however training human resources are not provided and the director has to look after the whole affairs in IQAU.
- * No telephone, internet, inter communication etc for communication to outside environment for quality issues.
