# Constraints faced by IQAU (3 most pressing)

- All universities have quality problems and the identified issues are neither unique or insurmountable as educational processes are affected by many internal and external factors
- Commitment from all the internal stakeholders was essential to conduct any institutional quality process for improvement



# Constraints faced by IQAU (3 most pressing)

- Grass root level acceptance of QA practices rather slow
- Part time IQAU officials and lack of logistic support are not favourable for sustaining QA culture
